Diana Mullis, M.D.

Dr. Diana Mullis holds a faculty position as Clinical Associate Professor with the Department of Psychiatry and Behavioral Sciences at the Medical University of South Carolina (MUSC). She also holds the positions of Medical Director Adult Services, Mental Health ICCE; Associate Director, Psychiatry Hospitalist Division; and Director of the Community and Public Safety Psychiatry Division, which includes the Forensic Program. She serves on several committees in the Department of Psychiatry, Medical University, and served on national organization committees, including past Chair of the Law Enforcement Liaison Committee of American Academy of Psychiatry and Law.

Dr. Mullis earned her medical degree from the Medical University of South Carolina and completed her residency training in Psychiatry and a Forensic Psychiatry fellowship at MUSC. She is Board-certified in Psychiatry, Forensic Psychiatry and is a Diplomate of the American Board of Psychiatry and Neurology. Dr. Mullis maintains a clinical and forensic psychiatric and actively participates as a faculty member to train and supervise medical students, residents, and fellows.



Edward "Thomas" Lewis III, M.D.

Dr. Edward Thomas Lewis III is a clinical assistant professor of psychiatry at the Medical University of South Carolina (MUSC) and Associate Dean for Student Progress in the College of Medicine. He completed his medical school and residency training in general psychiatry at MUSC as well. He then went on to complete an addiction psychiatry fellowship and a forensic psychiatry fellowship. He is triple boarded in adult general psychiatry, addiction psychiatry, and forensic psychiatry.

In his current role, Dr. Lewis is the attending physician on the addictions inpatient unit at the MUSC Institute of Psychiatry, where he oversees treatment including detox from substances, acute crisis stabilization, and management of co-occurring mental health concerns. He also serves as the forensic psychiatry fellowship director at MUSC. Dr. Lewis has been recognized as an expert witness in forensic psychiatry by the South Carolina court of general sessions. He conducts forensic evaluations and has provided psychiatric treatment to inmates within the South Carolina Department of Corrections.

Dr. Lewis is involved in organizational psychiatry. He is a South Carolina Representative on the American Psychiatric Association Assembly and a national membership committee member. Dr. Lewis is a past President of the South Carolina Psychiatric Association, the only state-wide association for psychiatric physicians in South Carolina, representing over 400 members.
